**APPLICATION FOR OUT OF STATE TUITION DIFFERENTIAL WAIVER FOR**  
**PRESIDENTIAL ACADEMIC WAIVER-HONORS COLLEGE**

An Out-of-State Student who has been admitted to the Honors College may apply for a Presidential Academic Out-of-State Tuition Waiver. If approved by the Kennesaw State University President, the waiver will be placed on the student's account for a minimum of one semester to a maximum of 12 months. The waiver may be removed at the request of the Honors College at any time if the student no longer meets the waiver requirements set forth by the Honors College. The student must maintain good standing with the Honors Program, and hold a 3.25 Cumulative GPA. For the award to be renewed, the student's Cumulative GPA and Satisfactory Academic Progress (SAP) GPA will be reviewed at the end of the most recently awarded semester. If the cumulative GPA is below a 3.25 or if the SAP GPA is below a 2.5, or if the student is no longer in good standing with the Honors Program, the student's waiver may be removed. This is in adherence to Board of Regents Policy 7.3.4.1 Out-of-State Tuition Waivers. Additionally, I further understand that any such false statement may subject me to immediate dismissal from the institution.

I understand this waiver, if approved, is valid for 12 months and I must maintain a 3.25 Cumulative GPA as a STEAM major or a 3.5 Cumulative GPA as a Non-STEAM major and a 2.5 SAP GPA to continue my waiver. I understand I must also maintain a lawfully present status in the United States and if my status changes at any point I must report that to the Honors College and the Tuition Classification Officer. I also understand that my waiver may be removed if I no longer meet the program requirements set forth by the Honors College.
