



Meaningful Honors Contracts involve proactive students who negotiate with a course instructor to develop an assignment or other product that deepens or extends learning within a course the student is currently taking. An Honors Contract should represent approximately 15 hours of work beyond regular course requirements (or about one hour/week of a 15-week semester) and align with one or more of the eight Foundations of Honors Learning.

### **Student Role**

Review the Honors Contracts: Instructions and Guidelines for Students on the KSU Journey Honors College website and the Honors D2L page.

Identify a course in which you would like to deepen your understanding or explore related topics.

Review course syllabus and calendar and brainstorm ideas for a project that would be meaningful to you based on your interests and goals.

Thoughtfully consider and research different possibilities until you have decided on two or three potential topics for your Honors Contract.

Set up a meeting with your faculty member and discuss potential ideas for the contract. Be open to changes as suggested by the faculty member. Decide on a specific topic and product (which may be an extension or addition to an existing course assignment).

Fill out the D2L proposal form. If your project is approved, fill out the DocuSign form for faculty approval.

Meet with the instructor throughout the semester to seek feedback and guidance, as well as to communicate progress to date.

Submit final product/evidence of Honors Contract completion to the course instructor and KSU Journey Honors College.

### **Faculty Role**

Negotiate with the student what topic and product might be meaningful in helping the student explore course topics or deepen their understanding of course topics in alignment with one or more of the eight Foundations of Honors Learning (Leadership, Critical Thinking, Professionalism, Interdisciplinary Learning, Appreciation of Diverse Viewpoints, Information Fluency, Creativity & Innovation, and Effective Communication).

Review the updated expectations for Honors contracts on the University Honors Program website. Contact [honors@kennesaw.edu](mailto:honors@kennesaw.edu) with any questions.

Be available to meet with the students as needed to serve as a resource and to provide feedback or guidance.

Review the student's final product.

A DocuSign form will be sent at the end of the semester asking for feedback on the completion and quality of the agreed-upon product. You will also be asked whether the student earned a "C" or better in the course, which is necessary for the Honors contract to count.

## How to Initiate an Honors Contract Conversation with your Professor

The product of the Honors contract may involve the extension of an existing course assignment or project or the addition of an assignment or project.

Many different kinds of products are acceptable to the Honors College, depending on the nature of the course, your goals, and the instructor’s preferences. Some possibilities include:
